Staff Report

UDC Report to CPC

Alex Dandridge, UDC Secretary, presented the application.

Almond asked if the Committee had questions for Mr. Dandridge or the applicant. Pearson asked what their purview was since it's a resubmission.

Pearson asked the applicant about the logic behind the layout, since the sidewalk is blocked a little.

The applicant, Drew Harrigan, said that they did some public charrettes, and they really wanted to do something unique and eye-catching at the corner of the property. It also gave space for street trees and bioretention basin, and a public utility pole. It was largely aesthetic.

Gemmer asked if there were any worries about mulch washing away in the retention areas between the sidewalk and Essex Street. Mr. Harrigan said that the space would be turf with street trees planted into it. Grass clippings won't get into it. Gemmer asked about Bio Basin A – Harrigan said that would be heavily planted with trees, shrubs, and dense perennials.

Quilici asked if there is an opportunity to add seating areas. Harrigan said unfortunately not because the branch manager said that they don't want to encourage any loitering or congregating, which is a pretty serious problem the library deals with. Almond added that this particular block has a lot of problems with prostitution and other types of loitering at this library.

Clarke said that volunteers would do the maintenance and planting. She wanted to know why this isn't the City's responsibility. Harrigan said that it would only be for the plantings only, but that it would be maintained by a private contractor.

Hepp-Buchanan asked where the bike share will be located. Harrigan showed it would be to the north of the building.

Woodson said bees would be negatively affected by herbicides. Harrigan said that they wanted to make one part of the property for herbaceous perennials and pollinators – explicit bee zones where there herbicides will not be used.

Clarke said she agrees with Woodson, since pesticides drift. It would be sad to invite bees and then spray around them with pesticides. She said there are bee-friendly pesticides. Moving forward we should request these things. Harrigan said that maintenance manuals provided to contracts could have these requests stated.

Woodson asked if they could change the language in the narrative to say organic or bee-friendly herbicides.

Almond opened the floor to public comment.

Emily Yeatts said that she's thrilled to see this project and excited about it as a member of the neighborhood.

Jennifer Clarke, DPU, said that the bike share will be a really interesting addition and will be added to the Ginter Park Library too.

Woodson said he wanted to thank Mr. Harrigan for his good work on this project.

Almond closed public comment and opened the floor for Committee discussion.

A motion was made by Committee Member Hepp-Buchanan, seconded by Committee Member Woodson, to approve UDC 2022-01 final location, character, and extent review of north avenue branch public library site improvements with the following conditions:

-The maintenance manual for the site be revised to specify that only organic, chemical-free pesticides and weed control be utilized on the entire site, and not just the Bee Zones.

### UDC Report to CPC

Alex Dandridge presented the application.

Quilici asked why the new bike share location is so far from the entrance. Mr. Harrigan, the applicant, said that the bike share stations function best when they're in a highly visible location from public rights-of-way. Brandon King reiterated the fact.

Quilici asked if it could be moved closer to the entrance, still on Warwick Road. Mr. Harrigan said there is some elevation change around the area; the location they chose is perfectly flat. Clarke asked if it has to be put somewhere flat; Mr. Harrigan said no, but there would be extra costs. Quilici asked if there is a bike path or routes that connects where the racks are. Mr. King said there is a planned bike lane going to Warwick Road. Quilici said his preference would be to make the bike share closer to the library if it can be done in a cost effective way. Mr. Harrigan said that the intersection of Broad Rock and Warwick is very busy, and that riders can immediately and easily get off the road with the location of the bike share.

Woodson added that the bee-friendly herbicide should be added in this application as well.

Almond opened the floor to public comment.

Jennifer Clarke, DPU, said that they're very excited for this. 9th District doesn't have a library, so this is pretty essential. And this will be one of the first bike share stations in Southside and 8th District.

Almond opened the floor for Committee discussion.

Clarke said she wasn't at the initial meeting, but this library seems to have a lot of greenspace and could provide an opportunity for education, so they should have a native plant demonstration garden. Mr. Harrigan said they're trying to work towards that. The interpretive sign will be the first thing you see when you come in, and it will be densely planted with natives; 3 different native species will be featured on each interpretive sign.

A motion was made by Committee Member Hepp-Buchanan, seconded by Committee Member Woodson, to approve UDC 2022-02 final location, character, and extent review of broad rock branch public library site improvements with the following conditions:

-The maintenance manual for the site be revised to specify that only organic, chemical-free pesticides and weed control be utilized on the entire site, and not just the Bee Zones.
