To amend Ord. THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That Article I, Section 1 of Ordinance No. 2024-099, adopted May 13, 2024, which adopted a General Fund Budget for the fiscal year commencing July 1, 2024, and ending June 30, 2025, and made appropriations pursuant thereto, is hereby amended by:

- (a) Transferring \$1,000,000.00 from the Non-Departmental agency Eviction Diversion Program line item for the fiscal year commencing July 1, 2024, and ending June 30, 2025;
- (b) Creating a new line item in the Non-Departmental agency entitled “Non-Departmental -

Eviction Diversion Program - Southside Community Development and Housing Corporation;” and

(c) Appropriating the funds in the amount of \$1,000,000.00 transferred by subsection (a) of this section to the new line item in the Non-Departmental agency created by subsection (b) of this section entitled “Non-Departmental - Eviction Diversion Program - Southside Community Development and Housing Corporation” for the purpose of providing funding to the Southside Community Development and Housing Corporation for the implementation of the City’s Eviction Diversion Program.

§ 2. This ordinance shall be in force and effect upon adoption.
