THE CITY OF RICHMOND HEREBY ORDAINS:

- § 1. That Article I, Section 1 of Ordinance No. 2024-099, adopted May 13, 2024, which adopted a General Fund Budget for the fiscal year commencing July 1, 2024, and ending June 30, 2025, and made appropriations pursuant thereto, is hereby amended by:
 - (a) Transferring \$1,000,000.00 from the Non-Departmental agency Eviction Diversion Program line item for the fiscal year commencing July 1, 2024, and ending June 30, 2025;
 - (b) Creating a new line item in the Non-Departmental agency entitled "Non-Departmental -

Eviction Diversion Program - Southside Community Development and Housing Corporation;" and

- (c) Appropriating the funds in the amount of \$1,000,000.00 transferred by subsection (a) of this section to the new line item in the Non-Departmental agency created by subsection (b) of this section entitled "Non-Departmental Eviction Diversion Program Southside Community Development and Housing Corporation" for the purpose of providing funding to the Southside Community Development and Housing Corporation for the implementation of the City's Eviction Diversion Program.
- § 2. This ordinance shall be in force and effect upon adoption.
