Title: To authorize the Chief Administrative Officer to accept funds in the amount of \$46,976.00 from the Virginia Department of Criminal Justice Services, to amend the Fiscal Year 2021-2022 Special Fund Budget by creating a new special fund for the Office of the Commonwealth’s Attorney for the City of Richmond called the Restorative Justice Special Fund, and to appropriate the increase to the Fiscal Year 2021-2022 Special Fund Budget by increasing estimated revenues and the amount appropriated to the Office of the Commonwealth’s Attorney for the City of Richmond’s Restorative Justice Special Fund by \$46,976.00 for the purpose of funding referrals to restorative justice conferencing and educational activities to promote awareness of the restorative justice process as an alternative to entering the criminal justice system.

THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That the Chief Administrative Officer is authorized to accept funds in the amount of \$46,976.00 from the Virginia Department of Criminal Justice Services for the purpose of funding referrals to restorative justice conferencing and educational activities to promote awareness of the restorative justice process as an alternative to entering the criminal justice system.

§ 2. That Ordinance No. 2021-041, adopted May 24, 2021, which adopted a Special Fund Budget for the fiscal year commencing July 1, 2021, and ending June 30, 2022, and made appropriations pursuant thereto, be and is hereby amended by creating a new special fund for the Office of the Commonwealth's Attorney for the City of Richmond called the Restorative Justice Special Fund for the purpose of funding referrals to restorative justice conferencing and educational activities to promote awareness of the restorative justice process as an alternative to entering the criminal justice system.

§ 3. That the funds received from the Virginia Department of Criminal Justice Services are hereby appropriated to the Special Fund Budget for the fiscal year commencing July 1, 2021, and ending June 30, 2022, by increasing estimated revenues by \$46,976.00, increasing the amount appropriated for expenditures by \$46,976.00, and allotting to the Office of the Commonwealth's Attorney for the City of Richmond's Restorative Justice Special Fund the sum of \$46,976.00 for the purpose of funding referrals to restorative justice conferencing and educational activities to promote awareness of the restorative justice process as an alternative to entering the criminal justice system.

§ 4. This ordinance shall be in force and effect upon adoption.
