## THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That Article I, Section 1 of Ordinance No. 2023-071, adopted May 8, 2023, which adopted a General Fund Budget for the fiscal year commencing July 1, 2023, and ending June 30, 2024, and made appropriations pursuant thereto, is hereby amended by:

(a) Transferring the total amount of \$250,000.00 from the Office of the Deputy Chief

Administrative Officer for Human Services for the fiscal year commencing July 1, 2023, and ending June 30, 2024;

- (b) Transferring the total amount of \$17,320.00 from the Non-Departmental agency "Reserve for Children's Fund" line item for the fiscal year commencing July 1, 2023, and ending June 30, 2024;
- (c) Creating a new line item in the Non-Departmental agency entitled "Ring vs. Rent Scholarship Foundation (for School Year 2023-24 MLK MS Leadership Program);" and
- (d) Appropriating \$267,320.00 of the funds transferred by subsections (a) through

  (b) of this section to the new line item in the Non-Departmental agency created by subsection (c) of this section entitled "Ring v. Rent Scholarship Foundation (for School Year 2023-24 MLK MS Leadership Program)," all for the purpose of purpose of supporting leadership programming for students at Martin Luther King, Jr., Middle School.
  - § 2. This ordinance shall be in force and effect upon adoption.
