§ 2. That Ordinance No. 2019-042, adopted May 13, 2019, which adopted a Special Fund Budget for the fiscal year commencing July 1, 2019, and ending June 30, 2020, and made appropriations pursuant thereto, be and is hereby amended by creating a new special fund for the Department of Fire and Emergency Services called the Fire Special Events Special Fund for the purpose of providing funding for expenses related to a firefighter training event to be held September 4, 2019, through September 6, 2019.

§ 3. That Ordinance No. 2019-042, adopted May 13, 2019, which adopted a Special Fund Budget for the fiscal year commencing July 1, 2019, and ending June 30, 2020, and made appropriations pursuant thereto, be and is hereby amended by increasing revenues from the funds accepted pursuant to section 1 of this ordinance by \$13,500, and increasing the amount appropriated to the Department of Fire and Emergency Services' Fire Special Events Special Fund for the purpose of providing funding for expenses related to a firefighter training event to be held September 4, 2019, through September 6, 2019.

§ 4. This ordinance shall be in force and effect upon adoption.
