THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That Ordinance No. 2021-040, adopted May 24, 2021, which adopted a General Fund Budget

for the fiscal year commencing July 1, 2021, and ending June 30, 2022, and made appropriations pursuant

thereto, is hereby amended by:

- (a) Creating the following new line items in the Non-Departmental agency:
 - (1) ARPA HCD Homeward Greater Richmond Continuum of Care Homeless Connection

Line;

(2) ARPA - HCD - Daily Planet, Incorporated - Medical Respite Services;

(3) ARPA - HCD - Southside Community Development and Housing Corporation - Post Purchase Counseling;

(4) ARPA - HCD - St. Joseph's Villa - Youth Outreach; and

(5) ARPA - HCD - CARITAS - Emergency Shelter Retrofits;

(b) Transferring \$1,283,288.00 from the Department of Housing and Community Development; and

(c) Appropriating these transferred funds to the following new line items in the Non-Departmental agency created by subsection (a) of this section in the following amounts:

(1) ARPA - HCD - Homeward - Greater Richmond Continuum of Care Homeless ConnectionLine . . . \$264,170.00;

(2) ARPA - HCD - Daily Planet, Incorporated - Medical Respite Services . . . \$350,400.00;

(3) ARPA - HCD - Southside Community Development and Housing Corporation - Post-Purchase Counseling . . . \$78,718.00;

(4) ARPA - HCD - St. Joseph's Villa - Youth Outreach . . . \$240,000.00; and

(5) ARPA - HCD - CARITAS - Emergency Shelter Retrofits . . . \$350,000.00,

all for the purpose of providing grants to certain entities for the provision of housing-related services.

§ 2. This ordinance shall be in force and effect upon adoption.
