§ 1. That Ordinance No. 2021-040, adopted May 24, 2021, which adopted the General Fund Budget for the fiscal year commencing July 1, 2021, and ending June 30, 2022, and made appropriations pursuant thereto, is hereby amended by modifying the attachment entitled "Council FY 2022 District Funds" to strike the page entitled "FY 22 Council 8th District Anticipated Expense Sheet" and insert in its place the page attached to this ordinance entitled "FY22 Council 8th District Anticipated Expense Sheet (Amended)," for the purpose of changing the uses and allocation of the Council District Funds for the Eighth District pursuant to section 15.2-2503 of the Code of Virginia (1950), as amended, for the use of the Council Member in the representation of the Eighth District.

§ 2. This ordinance shall be in force and effect upon adoption.
