THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That the Chief Administrative Officer, for an on behalf of the City of Richmond, is hereby authorized to accept funds in the amount of \$2,097,416.68 from the School Board of the City of Richmond for the purpose of funding payments to providers of emergency childcare and virtual learning support through the end of the 2020-2021 school year and reimbursing the City for payments made by the City in February, 2021, to four providers of emergency childcare and virtual learning support.

§ 2. That the funds received are hereby appropriated to the General Fund Budget for the fiscal year commencing July 1, 2020, and ending June 30, 2021, by increasing estimated revenues by \$2,097,416.68, increasing the

amount appropriated for expenditures by \$2,097,416.68, and allotting to the Office of the Deputy Chief Administrative Officer for Human Services the sum of \$2,097,416.68 for the purpose of funding payments to providers of emergency childcare and virtual learning support through the end of the 2020-2021 school year and reimbursing the City for payments made by the City in February, 2021, to four providers of emergency childcare and virtual learning support

§ 3. This ordinance shall be in force and effect upon adoption.
