WHEREAS, the Council believes that it is in the best interests of the residents of the city of Richmond that the Mayor promptly recommend an appropriate amendment to Ord. No. 2018-059, adopted May 14, 2018, which accepted a program of proposed Capital Improvement Projects for the fiscal year beginning July 1, 2018, and for the four fiscal years thereafter, and which adopted a Capital Budget for the fiscal year beginning July 1,

2018, and ending June 30, 2019, to appropriate the funds assigned to the Capital Maintenance Reserve from the general fund balance for the fiscal year commencing July 1, 2017, and ending June 30, 2018, for the maintenance of roads and sidewalks;
