THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That the Chief Administrative Officer is authorized to accept funds in the amount of \$300,000.00 from the Virginia Department of Social Services for the purpose of retaining program personnel to provide training and certain supportive services to participants in the RVA Guiding People to Success program.

§ 2. That Ordinance No. 2019-042, adopted May 13, 2019, which adopted a Special Fund Budget for the fiscal year commencing July 1, 2019, and ending June 30, 2020, and made appropriations pursuant thereto, be and is hereby amended by increasing revenues from the funds accepted pursuant to section 1 of this ordinance by \$300,000.00 and increasing the amount appropriated to the Office of Community Wealth Building's TANF RVA GPS special fund by \$300,000.00 for the purpose of retaining program personnel to
