**Title:** To authorize the Chief Administrative Officer to accept funds in the amount of \$43,127.00 from the Virginia Department of Criminal Justice Services; to amend the Fiscal Year 2019-2020 Special Fund Budget by creating a new special fund for the Department of Justice Services called the RED-Race Ethnic Disparity Special Fund; and to appropriate the increase to the Fiscal Year 2019-2020 Special Fund Budget by increasing estimated revenues and the amount appropriated to the Department of Justice Services' RED-Race Ethnic Disparity Special Fund by \$43,127.00 for the purpose of funding a readiness assessment related to equitable treatment of juvenile status offenders and participation in the Georgetown University Certificate Program for reducing racial and ethnic disparities in the juvenile justice system.

**THE CITY OF RICHMOND HEREBY ORDAINS:**

§ 1. That the Chief Administrative Officer, for and on behalf of the City of Richmond, is authorized to accept funds in the amount of \$43,127.00 from the Virginia Department of Criminal Justice Services for the purpose of funding a readiness assessment related to equitable treatment of juvenile status offenders and participation in the Georgetown University Certificate Program for reducing racial and ethnic disparities in the juvenile justice system.

§ 2. That Ordinance No. 2019-042, adopted May 13, 2019, which adopted a Special Fund Budget for the fiscal year commencing July 1, 2019, and ending June 30, 2020, and made appropriations pursuant thereto, be and is hereby amended by creating a new special fund for the Department of Justice Services called the RED -Race Ethnic Disparity Special Fund for the purpose of funding a readiness assessment related to equitable treatment of juvenile status offenders and participation in the Georgetown University Certificate Program for reducing racial and ethnic disparities in the juvenile justice system.

§ 3. That the funds received are hereby appropriated to the Special Fund Budget for the fiscal year commencing July 1, 2019, and ending June 30, 2020, by increasing estimated revenues by \$43,127.00, increasing the amount appropriated for expenditures by \$43,127.00, and allotting to the Department of Justice Services' RED-Race Ethnic Disparity Special Fund the sum of \$43,127.00 for the purpose of funding a readiness assessment related to equitable treatment of juvenile status offenders and participation in the Georgetown University Certificate Program for reducing racial and ethnic disparities in the juvenile justice system.

§ 4. This ordinance shall be in force and effect upon adoption.
