To adopt the Department of Parks, Recreation and Community Facilities' Richmond Cemeteries Budget for the fiscal year commencing Jul. 1, 2020, and ending Jun. 30, 2021, and to appropriate the estimated receipts of the Richmond Cemeteries for the said fiscal year for the operation and management of the facilities. THE CITY OF RICHMOND HEREBY ORDAINS:

- § 1. That the budget designated the Department of Parks, Recreation and Community Facilities' Richmond Cemeteries Budget for the fiscal year commencing July 1, 2020, and ending June 30, 2021, is hereby adopted.
- § 2. That the sum of \$1,799,421 be and is hereby appropriated from the estimated receipts of the Richmond Cemeteries for the fiscal year commencing July 1, 2020, and ending June 30, 2021, for the purposes as set forth in the Department of Parks, Recreation and Community Facilities' Richmond Cemeteries Budget.
- § 3. That the payment and settlement of claims of any kind heretofore or hereafter asserted against

the City growing out of the operation of the Richmond Cemeteries and final judgments heretofore or hereafter asserted against the City on account thereof, together with all costs, interest, fees for legal services and all other fees and expenses incident thereto, and all fees, costs and other expenses incurred in providing legal and other services authorized by section 2-57 of the Code of the City of Richmond (2015), as amended, shall be paid upon the approval and order of the City Attorney from the funds herein appropriated for defraying the expense of operating the Richmond Cemeteries; except that in the case of judgments against the City, payment thereof shall be limited to the extent of funds available in the appropriation for that purpose.

§ 4. This ordinance shall be in force and effect at the first moment of the first day of July, 2020 and shall constitute the Richmond Cemeteries appropriation ordinance for the fiscal year commencing on that date.
