THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That the Chief Administrative Officer is hereby authorized to accept funds in the amount of \$75,000.00 from The Washington Football Charitable Foundation, Inc. for the purpose of funding the renovation of outdoor facilities and amenities at Hotchkiss Field Community Center located at 701 East Brookland Park Boulevard.

§ 2. That the funds received are hereby appropriated to the Capital Budget for the fiscal year commencing July 1, 2021, and ending June 30, 2022, by increasing estimated revenues by \$75,000.00, increasing the amount appropriated for expenditures by \$75,000.00, and allotting to the Department of Parks, Recreation and Community
