§ 1. That Ordinance No. 2021-040, adopted May 24, 2021, which adopted the General Fund Budget for the

§ 2. That Ordinance No. 2021-040, adopted May 24, 2021, which adopted the General Fund Budget for the fiscal year commencing July 1, 2021, and ending June 30, 2022, and made appropriations thereto, is hereby amended by appropriating the funds in the total amount of \$12,200,000.00 transferred pursuant to section 1 of this ordinance to the following new programs, with new program numbers to be assigned in accordance with the City's chart of accounts, within the Department of Finance in the following amounts for the purpose of implementing the City's spending plan for American Recovery Plan Act of 2021 funds:
