No. 2021-041, adopted May 24, 2021, which adopted the Fiscal Year 2021-2022 Special Fund Budget and made appropriations thereto, to appropriate such \$82,800.00 to the Department of Parks, Recreation, and Community Facilities' Youth Gun Violence Prevention Program Special Fund, all for the purpose of providing additional funding for the Department of Parks, Recreation, and Community Facilities' youth gun violence prevention programming.

THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That Ordinance No. 2021-040, adopted May 24, 2021, which adopted a General Fund Budget for the fiscal year commencing July 1, 2021, and ending June 30, 2022, and made appropriations pursuant thereto, is hereby amended by transferring \$82,800.00 from the Communities in Schools of Richmond, Inc., line item in the Non-Departmental agency.

§ 2. That Ordinance No. 2021-041, adopted May 24, 2021, which adopted a Special Fund Budget for the fiscal year commencing July 1, 2021, and ending June 30, 2022, and made appropriations pursuant thereto, be and is

hereby amended by increasing revenues from the funds transferred pursuant to section 1 of this ordinance by \$82,800.00 and increasing the amount appropriated to the Department of Parks, Recreations, and Community Facilities' Youth Gun Violence Prevention Program Special Fund by \$82,800.00 for the purpose of providing additional funding for the Department of Parks, Recreation, and Community Facilities' youth gun violence prevention programming.

§ 3. This ordinance shall be in force and effect upon adoption.
