adopts a resolution approving it; and

WHEREAS, the City, with the assistance of TIP Strategies, Inc., an economic development consulting firm, has

developed the plan entitled "Strategic Plan for Equitable Economic Development" (the "Plan"), a copy of which plan is

attached to this resolution, pursuant to section 2-1373 of the Code of the City of Richmond (2020), as amended; and

WHEREAS, the Council believes it is in the best interests of the citizens of the City of Richmond that the Council
