THE CITY OF RICHMOND HEREBY ORDAINS:

- I. That Ordinance No. 2022-195, adopted July 25, 2022, is hereby amended and reordained as follows:
- § 1. That the Chief Administrative Officer, for and on behalf of the City of Richmond, be and is hereby authorized to execute a Friends Association Grant Contract between the City of Richmond and [Friends] The FRIENDS' Association for Children [Endowment Fund, Inc.], for the purpose of stabilizing [Friends] The FRIENDS' Association for [Children Endowment Fund, Inc.'s] Children's child care and preschool programs. be approved as to form by the City Attorney and shall be substantially in the form of the <u>revised</u> document attached to this ordinance.
