THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That the Chief Administrative Officer is authorized to accept funds in the amount of \$2,000,000.00 from the Virginia Department of Historic Resources for the purpose of funding the Virginia Museum of History and Culture's History Matters Campaign capital improvements project.

§ 2. That Ordinance No. 2022-056, adopted May 9, 2022, which adopted the Special Fund Budget

for the fiscal year commencing July 1, 2022, and ending June 30, 2023, and made appropriations pursuant thereto, be and is hereby amended by creating a new special fund for the Department of Planning and Development Review called the Virginia Museum of History and Culture Project DHR Historic Preservation Grant Special Fund, for the purpose of funding the Virginia Museum of History and Culture's History Matters Campaign capital improvements project.

- § 3. That the funds received from the Virginia Department of Historic Resources are hereby appropriated to the Special Fund Budget for the fiscal year commencing July 1, 2022, and ending June 30, 2023, by increasing estimated revenues by \$2,000,000.00, increasing the amount appropriated for expenditures by \$2,000,000.00, and allotting to the Department of Planning and Development Review's Virginia Museum of History and Culture Project DHR Historic Preservation Grant Special Fund the sum of \$2,000,000.00, for the purpose of funding the Virginia Museum of History and Culture's History Matters Campaign capital improvements project.
 - § 4. This ordinance shall be in force and effect upon adoption.
