That Ordinance No. 2020-055, adopted May 9, 2022, which adopted a General Fund Budget for the fiscal § 1. year commencing July 1, 2022, and ending June 30, 2023, and made appropriations pursuant thereto, is hereby amended by

- (b) Creating a new line item in the Non-Departmental agency entitled "Venture Richmond Inc. (Graffiti Removal Downtown);" and
- (c) Appropriating the funds in the amount of \$75,000.00 transferred by subsection (a) of this section to the new line item in the Non-Departmental agency created by subsection (b) of this section entitled "Venture Richmond Inc. (Graffiti Removal Downtown)" for the purpose of funding graffiti removal in the downtown service area.
