WHEREAS, pursuant to section 44-146.21(A) of the Code of Virginia (1950), as amended, the Council consented to the Mayor's declaration of such states of emergency by Resolution No. 2009-R22-30, adopted March 9, 2009, concerning a major snowstorm, Resolution No. 2011-R93-92, adopted September 6, 2011, concerning Hurricane Irene, Resolution No. 2020-R041, June 8, 2020, concerning civil unrest, and Resolution No. 2021-R006, adopted January 11, 2021, concerning potential civil unrest; and

That, pursuant to section 44-146.2I(A) of the Code of Virginia (1950), as amended, Resolution No. 2009-R22-30, adopted March 9, 2009, concerning a major snowstorm, Resolution No. 2011-R93-92, adopted September 6, 2011, concerning Hurricane Irene, Resolution No. 2020-R041, adopted June 8, 2020, concerning civil unrest, and Resolution No. 2021-R006, adopted January 11, 2021, concerning potential civil unrest, be and are hereby repealed, as those respective states of emergency no longer exist.
