- That Article I, Section 1 of Ordinance No. 2023-071, adopted May 8, 2023, which adopted a General Fund Budget for the fiscal year commencing July 1, 2023, and ending June 30, 2024, and made appropriations pursuant thereto, is hereby amended by
- Transferring \$250,000.00 from the Non-Departmental agency Reserve for Richmond Outdoor and Prosperity Fund line item for the fiscal year commencing July 1, 2023, and ending June 30, 2024;
- (b) Creating a new line item in the Non-Departmental agency entitled "The Community Foundation, Inc." and
- Appropriating the funds in the amount of \$250,000.00 transferred by subsection (a) of this section to the (c) new line item in the Non-Departmental agency created by subsection (b) of this section entitled "The Community Foundation, Inc." for the purpose of administering funds for outdoor projects within the city of
